The Advisor may be deemed to beneficially own an aggregate of 600,000 warrants, consisting of 395,340 warrants held by RP Select Opportunities Master Fund Ltd., 196,560 warrants held by RP Debt Opportunities Fund Ltd. and 8,100 warrants held by RP Alternative Global Bond Fund. Each whole warrant entitles the holder thereof to purchase one share of Class A common stock, and only whole warrants are exercisable. Each warrant will become exercisable on the later of 30 days after the completion of an initial business combination ("Initial Business Combination"), as described in more detail in the Issuer's prospectus dated November 7, 2019 and filed with the SEC on November 8, 2019 (the "Prospectus"), or 12 months from the date of the Prospectus, and will expire five years after the completion of the Initial Business Combination or earlier upon redemption or liquidation. The warrants are not presently exercisable and contain provisions that would prevent the holder from exercising in the event that it would cause the holder to beneficially own in excess of 4.9% or 9.8% (or such other amount as specified by the holder) of the Issuer's outstanding shares of common stock.
